We are very happy with the big green drug eating box! The patients have taken right to using it and we observe folks bring expired meds by many times each day. I have been told multiple times over the last several months that the patients appreciate being able to bring in their expired medications when they are picking up other prescriptions. They like not having to go to the police station or to the drug take-back sites. We also had a good response by teaching folks picking up narcotic prescriptions that are for acute use and telling them that when the medications are no longer needed, they can simply return them to the green box that is right behind them and they will be properly disposed of instead of sitting at home where they may be diverted.

After having it installed now since January, I cannot figure out why we have not had a similar program for the last 20 years that the pharmacy has existed. I cannot imagine having a pharmacy without the green box!
